

## **NOTICE OF PUBLIC HEARING**

### **Evansville MPO FY 2018 FTA Section 5310 Grant Application**

Notice is hereby given that the Evansville Metropolitan Planning Organization (MPO) will submit a Federal Transit Administration (FTA) grant application for Section 5310 funds. The Evansville MPO is the Designated Recipient of the FTA Section 5310: Enhanced Mobility of Seniors and Individuals with Disabilities Grant Program for non-profit organizations in the Evansville Urbanized Area. The purpose of this notice is to afford all interested persons the opportunity to comment on the proposed projects.

Comments will be accepted through April 12, 2018. Oral comments can be made at one of two public hearings held by the Evansville MPO on April 12, 2018 in the Civic Center Complex: Technical Committee Meeting at 10:00 AM in Room 318 or Policy Committee Meeting at 4:00 PM in Room 301.

**Low-Floor Minivan:** The MPO received a request for funding assistance from The Arc of Evansville to acquire a low-floor minivan. The grant application will request \$28,000 in Section 5310 funds that The Arc of Evansville will match with \$7,000 for a total vehicle cost of \$35,000.

**Small Transit Vehicles:** The MPO received a request for funding assistance from the Warrick County Council on Aging (WCCOA) to acquire two small transit vehicles. The grant application will request \$85,305 in Section 5310 funds that WCCOA will match with \$21,326 for a total cost of \$106,631.

**Planning:** The grant application will request 10% (approximately \$22,000) of the Federal FY 2018 FTA apportionment of Section 5310 funds for the Evansville Urbanized Area for grant administration and planning for FY 2019.
