The Evansville Metropolitan Planning Organization has processed the following administrative modifications to the FY 2016-2019 Transportation Improvement Program (TIP).

TIP Administrative Modification

Warrick County requested the following modification:

Des# 0500641 Oak Grove Road, Section 3: Bell Road to SR 261. Road widening project. Revise Right of Way (ROW) estimate and funding. Fiscal year 2017 ROW costs of \$1,045,000 are programmed with \$836,000 in federal Surface Transportation Program (STP) funds, and \$209,000 local funds.

The City of Evansville requested the following modification:

Des# 1383064 Covert Avenue: US 41 to I-69. Revise Right of Way (RW) schedule. Fiscal year 2018 RW costs of \$700,000 are programmed with \$300,000 in federal Congestion Mitigation and Air Quality (CMAQ) funds, and \$400,000 local funds.


The Town of Newburgh requested the following modification:

Des# 0710850 Rivertown Trail Ph. 3A: Trail construction from Yorkshire Drive to Pollack Ave/Old SR 662W. Revise CN schedule. CN costs of \$980,000 in fiscal year 2018 are programmed with \$601,000 in federal TAP funds, and \$379,000 local funds.
