Jack Corn directed the meeting.

2. ELECTION OF CHAIR AND VICE-CHAIR

Christy Powell nominated Jack Corn for Chair; Jill Hahn seconded the motion. Christy Powell made a motion to close nominations; Mary Allen seconded the motion. The committee approved Jack Corn as Chair with a vote of acclamation.

Christy Powell nominated John Stoll for Vice-Chair; Rusty Fowler seconded the motion. John Stoll commented that he is also on the Building Commission Licensing Board that meets at 3:30 every Thursday, so there may be times that he will not be able to be at this meeting on time. Christy Powell made a motion to close nominations; Jill Hahn seconded the motion. The committee approved John Stoll as Vice-Chair with a vote of acclamation.

3. APPROVAL OF MINUTES

Christy Powell made a motion for approval and Jill Hahn seconded the motion; motion carried.

4. OLD BUSINESS

a. Project Update - presented by Pam Drach

City of Evansville

- Walnut St Phase 2 (Weinbach Ave to Vann Ave): The Boeke Rd intersection traffic signal is in full operation. The
 Vann Ave speed hump was closed on March 11 for construction work and will be closed for approximately three
 weeks.
- Walnut St Phase 3 (MLK Jr Blvd to US 41): Stormwater sewer installation is continuing at Beford Ave and Walnut St. Pavement removed on Walnut St from Kentucky Ave to Bedford Ave with installation of subgrade treatment at Bedford. City, contractors, designers, and CenterPoint met out in the field to address conflict between traffic signal strain pole and CenterPoint's transmission line. Relocation/redesign of traffic signal strain poles at Kentucky/Walnut is in the works.

Vanderburgh County

- Oak Hill Rd (Eastwood Dr to Millersburg Rd): Project was let for bid on January 18, 2024 and awarded to Koberstein Contracting Inc, for approximately \$8.44 million. The contractor will begin right-of-way clearing soon and is tentatively planning to close Oak Hill Rd beginning on March 27, 2024.
- Oak Hill Rd (Lynch Rd to St George Rd): A legal notice was published to advertise for the opportunity to request a public hearing. The IDEM Section 401 General Water Quality Certificate was approved on March 7, 2024. The Corps of Engineers permit application was submitted on March 1, 2024.
- <u>Wimberg Rd Bridge (over Locust Creek):</u> The hydraulic analysis was completed, and the alignment was set to allow phased construction at the site. The structure, size and type study is underway to determine the most cost effective structure; plans are being prepared for the utility verification request.

Warrick County

• Epworth Rd (SR 662 to south of SR 66): Preliminary field check moved to June 2024 to allow time for additional archeological studies.

City/County of Henderson

- Green River Rd (Bend Gate Rd to Osage Dr): District 2 is negotiating for the acquisition of the one remaining parcel. Targeting a summer 2024 letting.
- Wathen Lane (US 60 to City Limits): Bid opening was on January 5, 2024. The construction contract has been awarded to Yager Materials Corp for \$4.115 million. A public meeting was held on February 21, 2024.
 Construction began March 4 and is scheduled to be completed by December 15.

INDOT Updates – presented by Rusty Fowler

- (R-40567) SR 65 over I-64 Bridge Replacement: Bridge is gone; closure in place, construction on-going.
- (B-44156) US 41 over SR 66/Diamond Ave: Construction is complete.
- (B-42876) US 41 Pedestrian Walk at Washington Ave: Finalizing R/W acquisition, construction of foundations will begin soon.
- (R-41410) US 41 from SR 66/SR 62 (Lloyd) to SR 66 (Diamond): Shoulder strengthening is going down, drainage structures on the south end will be complete within two weeks, we expect to be in phase two with traffic switched to the southbound side by the end of April.
- (R-44898) Intersection Improvements on SR 66 (at Vann, Burkhardt, Cross Pointe, Stockwell): Contract was awarded to JBI for \$35,498,919.88. Pre-Construction meeting held 2/22/24. Construction is set to begin at Vann and Stockwell by July 1, 2024.
- (R-42287) SR 62 Lloyd4U project: Project has been advertised on a special letting 3/27/24.

Jack Corn asked about the roundabout project on 2nd St/Parrett St/Jefferson St. Pam Drach explained that there has been discussion with the city about whether that project is going to proceed. Michael Labitzke, City of Evansville Engineer, was in attendance and confirmed that the city is cutting that project. Jack Corn then asked when the rest of the Walnut St project will be finished, and Pam Drach answered (and Michael Labitzke confirmed) that the downtown section will go until 2025.

b. FY 2025 FTA Section 5303 Application Local Share – presented by Jennifer Scott

KYTC's application process for Federal Transit Administration Section 5303 Transit Planning Funds is entirely online. The enclosed resolution gives Seyed Shokouhzadeh authorization to upload the required documents for the Section 5303 application. Additionally, the resolution states that the Evansville MPO will provide the required 20% local match, which is currently part of the City of Henderson's local sharein the amount of \$2,500.

c. 2024 Title VI Goals and Accomplishments Report – presented by Jennifer Scott

At the beginning of each year, the Evansville MPO develops a list of Title VI accomplishments from the prior year and Title VI goals for the upcoming year. These goals and accomplishments include completed and upcoming trainings and workshops, updates to the Title VI documents and surveys, and the total number of Title VI complaints from the previous year.

The complete list forms the annual Title VI Goals and Accomplishments Report. This report will be added to the appendices of the *Title VI Implementation Plan & Limited English Proficiency Plan*.

This item was informational and did not require committee action.

d. 2024 Transit Targets (TAM & PTASP) – presented by Jennifer Scott

METS and HART have been required to develop annual Transit Asset Management (TAM) Targets since completion of the Group TAM Plan in September 2018. At the end of each year, the MPO gathers fleet data from METS and HART to calculate the end of the previous year Performance Metrics and set the end of the current year Targets. Although not required, the MPO also calculates Performance Metrics and sets Targets for the non-profit vehicles. With your approval of these Targets, the MPO will include them in the TIP and MTP documents. The following table includes TAM Performance Measure definitions, end of 2023 Performance Metrics, and end of 2024 TAM Targets.

Starting in 2021, METS and HART have also been required to develop annual Safety Targets. These Targets are listed in the Public Transit Agency Safety Plans (PTASP) for both METS and HART. The MPO worked with METS and HART to collect safety data to calculate Performance Metrics and set Targets. With your approval of these Targets, the MPO will include them in the TIP and MTP documents. The following table includes Safety Performance Measure definitions, end of 2022 Performance Metrics, and end of 2024 Safety Targets.

e. FY 2024 Transit Memorandum of Agreement – presented by Jennifer Scott

The Evansville Metropolitan Planning Organization is seeking approval of the following Fiscal Year 2024 Memorandum of Agreement (MOA):

• Memorandum of Agreement Between the Evansville Metropolitan Planning Organization (EMPO) and Henderson Area Rapid Transit (HART)

The MOA identifies activities the EMPO will perform in Fiscal Year 2024 for HART in exchange for compensation by HART. It also identifies the activities HART must complete in order for the EMPO to complete their tasks. The approval sheets can be found at the end of the MOA.

f. Evansville MPO FY 2023 Audit – presented by Kari Akin

The Evansville MPO FY 2023 Audit covering period July 1, 2022 to June 30, 2023 was conducted by Crowe LLP through a contract with the Indiana State Board of Accounts.

Copies of the audit have been sent to the state pass-through agencies, federal agencies, and the KY and IN state clearinghouses.

Pages 13 and 14 show the schedule of expenditures of federal awards. Eighteen grants were administered in FY 2023 totaling \$1,058,953 in federal expenditures. Of this total, \$67,500 were passed through to non-profits utilizing the Federal Transit Administration Section 5310 funds.

Page 21 lists the schedule of findings and questioned costs in which no matters were reportable.

g. Evansville MPO FY 2023 FTA ECHO Review – presented by Kari Akin

The Federal Transit Administration (FTA) COVID-19 Relief ECHO Drawdown Review – Final Report is an FTA oversight report that documents the COVID-19 Relief ECHO Drawdown Review of the Evansville MPO. This spot financial review is part of FTA's supplemental oversight for the funds that Congress appropriated to assist the transit industry with its COVID-19 response and recovery efforts. Although not an audit, this review provides an assessment of compliance with Federal requirements, determined by examining a sample of ECHO draws. As such, the review is not intended as, nor does it constitute, a comprehensive and final review of compliance with award requirements.

The final report documents the COVID-19 Relief ECHO Drawdown review process. No issues were identified during this review.
