

#### 1. ROLL CALL

#### 2. ELECTION OF CHAIR AND VICE-CHAIR

Mike Labitzke made a motion to nominate Nate Hahn for Chair; McKenzie May seconded the motion; motion carried.

McKenzie May made a motion to nominate Lorie Van Hook for the Vice-Chair; Mike Labitzke seconded the motion; motion carried.

#### 3. APPROVAL OF MINUTES

Thomas Witt made a motion for approval and Mike Labitzke seconded the motion; motion carried.

#### 4. OLD BUSINESS

#### a. Project Update – presented by Pam Drach

#### **City of Evansville**

- Walnut St Phase 2 (Weinbach Ave to Vann Ave): The Boeke Rd intersection traffic signal is in full operation. The Vann Ave speed hump was closed on March 11 for construction work and will be closed for approximately three weeks.
- Walnut St Phase 3 (MLK Jr Blvd to US 41): Stormwater sewer installation is continuing at Beford Ave and Walnut St. Pavement removed on Walnut St from Kentucky Ave to Bedford Ave with installation of subgrade treatment at Bedford. City, contractors, designers, and CenterPoint met out in the field to address conflict between

traffic signal strain pole and CenterPoint's transmission line. Relocation/redesign of traffic signal strain poles at Kentucky/Walnut is in the works.

#### **Vanderburgh County**

- Oak Hill Rd (Eastwood Dr to Millersburg Rd): Project was let for bid on January 18, 2024 and awarded to Koberstein Contracting Inc, for approximately \$8.44 million. The contractor will begin right-of-way clearing soon and is tentatively planning to close Oak Hill Rd beginning on March 27, 2024.
- Oak Hill Rd (Lynch Rd to St George Rd): A legal notice was published to advertise for the opportunity to request a public hearing. The IDEM Section 401 General Water Quality Certificate was approved on March 7, 2024. The Corps of Engineers permit application was submitted on March 1, 2024.
- <u>Wimberg Rd Bridge (over Locust Creek):</u> The hydraulic analysis was completed, and the alignment was set to allow phased construction at the site. The structure, size and type study is underway to determine the most cost effective structure; plans are being prepared for the utility verification request.

#### **Warrick County**

• Epworth Rd (SR 662 to south of SR 66): Preliminary field check moved to June 2024 to allow time for additional archeological studies.

#### **City/County of Henderson**

- Green River Rd (Bend Gate Rd to Osage Dr): District 2 is negotiating for the acquisition of the one remaining parcel. Targeting a summer 2024 letting.
- Wathen Lane (US 60 to City Limits): Bid opening was on January 5, 2024. The construction contract has been awarded to Yager Materials Corp for \$4.115 million. A public meeting was held on February 21, 2024.
   Construction began March 4 and is scheduled to be completed by December 15.

- (R-40567) SR 65 over I-64 Bridge Replacement: Closure in place, construction on-going.
- (B-44156) US 41 over SR 66/Diamond Ave: Construction is complete.
- (B-42876) US 41 Pedestrian Walk at Washington Ave: Finalizing R/W acquisition, construction of foundations will begin soon.
- (B-42187) I-64 over abandoned N and S RR: June 4<sup>th</sup> is the planned start date for construction.
- (R-41410) US 41 from SR 66/SR 62 (Lloyd) to SR 66 (Diamond): Shoulder strengthening is going down, drainage structures on the south end will be complete within two weeks, we expect to be in phase two with traffic switched to the southbound side by the end of April.
- (R-44898) Intersection Improvements on SR 66 (at Vann, Burkhardt, Cross Pointe, Stockwell): Contract was awarded to JBI for \$35,498,919.88. Pre-Construction meeting held 2/22/24. Construction is set to begin at Vann and Stockwell by July 1, 2024.
- (R-42748) SR 61 (Lynnville): Construction should begin early spring. Town is working with Commonwealth on lighting design.
- (R-42736) I-69 near US 41: Final Tracings have been submitted to Central Office.
- (B-42728) SR 62 bridge thin deck overlay: Contract awarded to Ram Construction with a winning bid of \$876,166.92.
- (R-42199) SR 66 from 2.76 mi west of US 41: Final Field Check scheduled for 5/14/2024.
- (R-42287) SR 62 Lloyd4U project: Project has been advertised on a special letting 3/27/24.

- <u>(B-43235) SR 68 over Mill Creek:</u> Permits acquired / all parcels are being secured. No delays/risk. Public involvement in the works.
- (R-44695) SR 68 from 1.2mi E. of US 41 to 4mi W. of SR 61 intersection: Letting date getting moved back up to October 2024 since the rebundling of projects.
- (B-45043) SR 161 over Coles Creek and SR 62 over Barren Fork: Project still moving forward.
- (B-43231) I-69 Bridge Painting around SR 662/SR62: Stage 2 files received /review as of 01/03/2024. Des# 2002134-2002135 will stay on contract. Limited Red Flag Investigation being requested for Des# 2002134 and Des# 2002135 (after discussion no need for expedited).
- (B-43986) SR 66 over UNT (1.45mi E. JCT SR 65): Submission for CE-1 (02/13/24) Resubmit for corrections. STG2 and Permits in the works.
- (R-44499) US 41 at SR 57, Petersburg Rd, and St George Rd: Kick-off meeting held, early development for Stage 1 plans and utility coordination meetings are on-going.

#### c. 2024 Transit Targets (TAM & PTASP) – presented by Jennifer Scott

METS and HART have been required to develop annual Transit Asset Management (TAM) Targets since completion of the Group TAM Plan in September 2018. At the end of each year, the MPO gathers fleet data from METS and HART to calculate the end of the previous year Performance Metrics and set the end of the current year Targets. Although not required, the MPO also calculates Performance Metrics and sets Targets for the non-profit vehicles. With your approval of these Targets, the MPO will include them in the TIP and MTP documents. The following table includes TAM Performance Measure definitions, end of 2023 Performance Metrics, and end of 2024 TAM Targets.

Starting in 2021, METS and HART have also been required to develop annual Safety Targets. These Targets are listed in the Public Transit Agency Safety Plans (PTASP) for both METS and HART. The MPO worked with METS and HART to collect safety data to calculate Performance Metrics and set Targets. With your approval of these Targets, the MPO will include them in the TIP and MTP documents. The following table includes Safety Performance Measure definitions, end of 2022 Performance Metrics, and end of 2024 Safety Targets.

**RE:** CY 2024 Call for Projects: Project Application and Prioritization Updates

**DATE:** May 2, 2024

This July, the Evansville MPO will be announcing a Notice of Funding Availability (Call for Projects) to Indiana LPAs for funding for FY 2031 and beyond. For this Call for Projects, the application will be completed and submitted through an online portal. This differs from the fillable PDF form from previous Calls for Projects. The only content change on this application is the addition of two questions under the Project Details section – Green Infrastructure and FHWA Proven Safety Countermeasures. All other application content is the same as the previous application.

A separate Excel file will be provided as part of the application process for the Project Budget.

A reference guide has been developed to assist LPAs in completing the application. The guide provides instructions on the online application process, details for each section of the application, and sample wording for the required financial commitment letter. The guide also includes the updated process and metrics the EMPO will use when prioritizing projects for federal funding.

The online application, project funding table, and guidance document are available for review before the Call for Projects announcement is made public in July. Approval of the updated application, reference guide and prioritization metrics are an action item at the May meetings.
